Underwriting Guidelines

This program is available only for eligible vehicles that have been inspected, certified, and issued a limited powertrain warranty by the manufacturer of the vehicle.

Term years begin on the "in-service" date; term mileage begins at zero miles.

In-Service Date: The vehicle's factory warranty start date or the vehicle's first day of use, whichever occurs first, regardless of the contract sale date.

Deductible: There is a \$100 deductible per repair visit, unless the *Disappearing Deductible Option* is checked in Part I.

Eligible Vehicles: The following vehicle makes are the only ones eligible for Factory+Plus Care contracts for certified used vehicles:

Completing Part I (Proof of Registration)

All copies must be legibly printed or typewritten. Strikeovers should be corrected on all copies and initialed by the customer. Complete all information and check appropriate boxes. For instructions on how to complete Part I, refer to the vehicle service contract procedure manual.

- **Program Coverage Selection**—check appropriate program coverage selection.
- **Deductible Option**—check \$100 Disappearing Deductible, if applicable.
- Specialty Option Package—available if box is checked in Part I and surcharge is paid.

Completing the Contract Register and Remittance Report

Factory+Plus Care contracts for certified used vehicles may be submitted with regular vehicle service contracts. Please follow instructions for completing the Contract Register and Remittance Report as outlined in the vehicle service contract procedure manual.

There is no need to complete a separate Contract Register and Remittance Report, as both regular vehicle service contracts and Factory+Plus Care contracts for certifed used vehicles may be combined on the same form.

Transfer

Factory+Plus Care contracts for certified used vehicles are not transferable.
